

# MUSIC LICENCE FORM - TARIFF 19 – PHYSICAL EXERCISES AND DANCE

## INSTRUCTION (dancercise, aerobics, body building etc.)

- Grants you permission to play (publicly perform) musical works in conjunction with physical exercises and dance instruction
- Annual fee is the annual average number of participants per week, multiplied by \$2.50 (minimum fee is \$74.72) + taxes for each room where music is played
- Deadline for SOCAN to receive forms and payments is January 31st of the year for which a licence is granted (except for first time reports)

1. In this form, you, your and licensee means the person or company applying for a licence or filing a Music Licence Form. We, our, us and SOCAN means the Society of Composers, Authors and Music Publishers of Canada. Works means any or all of the musical works in SOCAN's repertoire.

3. If the tariff for a year has not been certified by January 1st of that year, the last certified tariff will govern until the new version is certified, at which time adjustments will be made to reflect the certified tariff for the year.
4. This licence will automatically renew on January 1st unless terminated by either party upon 30 days' notice in writing.
5. The licence fee, plus applicable taxes, will be calculated in accordance with the terms of this licence based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
6. You will keep records of all information required to calculate the licence fees.
7. The licence fees and report forms are due no later than January 31st of the year covered by the licence, or within ten days of any adjustments.
