

**MUSIC LICENCE FORM - TARIFF 1B – NON-COMMERCIAL RADIO**  
 (AM/FM broadcast and internet if applicable)

- Grants you permission to communicate to the public musical works by a non-commercial AM or FM or internet-only radio station (other than CBC)
- Annual fee is 1.9% of the station's gross operating costs, including it's internet operating costs
- Fee calculation is based on an estimate for the current year's gross operating costs. e.g. if you are applying for a 2016 licence, you must indicate your 2015 actual gross operating costs
- Your licence fees are subject to adjustment upon determination of the actual costs for the year
- Deadline for SOCAN to receive forms and payments is January 31st of the year for which a licence is granted, except for first time reports

1. In this form, you, your and licensee means the person or company applying for a licence or filing a Music Licence Form. We, our, us and SOCAN means the Society of Composers, Authors and Music Publishers of Canada. Works means any or all of the musical works in SOCAN's repertoire.

3. If the tariff for a year has not been certified by January 1st of that year, the last certified tariff will govern until the new version is certified, at which time adjustments will be made to reflect the certified tariff for the year.
4. This licence will automatically renew on January 1st unless terminated by either party upon 30 days' notice in writing.
5. The licence fee, plus applicable taxes, will be calculated in accordance with the terms of this licence based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
6. You will keep records of all information required to calculate the licence fees.
7. The licence fees and report forms are due no later than January 31st of the year covered by the licence, or within ten days of any adjustments.
8. Report forms of the station's actual gross operating costs for that year and payment of any adjustment of the licence fees are due by January 31st of the year for which the licence is issued or within 10 days of any adjustments.
