

**MUSIC LICENCE FORM - TARIFF 21 – RECREATIONAL FACILITIES** operated by a municipality, school, college, university, agricultural society or similar community organizations

- Grants you permission to play (perform publicly) in public musical works during recreational activities that would otherwise be subject to the following tariffs:
  - Sports events incl. minor hockey, figure and roller skating, amateur rodeos etc. (tariff 9)
  - Skating rinks (Tariff 7)
  - Fitness activities and dance instruction(Tariff 19)
  - Receptions, conventions, assemblies or fashion shows (Tariff 8)
  - Exhibition and fairs (Tariff 5A)
  - Circuses, fireworks displays, ice or sound & light shows and similar events (Tariff 11A)
- Deadline for SOCAN to receive forms and payments is January 31st of the year for which a licence is granted

1. In this form, you, your and licensee means the person or company applying for a licence or filing a Music Licence Form. We, our, us and SOCAN means the Society of Composers, Authors and Music Publishers of Canada. Works means any or all of the musical works in SOCAN's repertoire.

3. If the tariff for a year has not been certified by January 1st of that year, the last certified tariff will govern until the new version is certified, at which time adjustments will be made to reflect the certified tariff for the year.
4. This licence will automatically renew on January 1st unless terminated by either party upon 30 days' notice in writing.
5. The licence fee, plus applicable taxes, will be calculated in accordance with the terms of this licence based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
6. You will keep records of all information required to calculate the licence fees.
7. The licence fees and report forms are due no later than January 31st of the year covered by the licence, or within ten days of any adjustments.
8. The licence fees and report (confirming that this licensee's gross revenue from the events covered by this tariff during the year does not exceed \$15,422.88) are due no later than January 31st of the year covered by the licence or within ten days of any adjustments.
