

MUSIC LICENCE FORM - TARIFF 3B – RECORDED MUSIC accompanying LIVE ENTERTAINMENT in eating/drinking establishments (bars, clubs, lounges, cabarets, cafés, dining rooms, etc.)

- Grants you permission to play (publicly perform) musical works by means of recorded music as an integral part of live entertainment
- Annual fee is 2% of the compensation paid for entertainment for the year (minimum fee is \$67.32 + taxes)
- Fee calculation is based on either the previous year's compensation paid for entertainment, or an estimate of the expected compensation (for the year covered by licence), if no music was performed in the previous year
- Deadline for SOCAN to receive forms and payments is January 31st of the year for which a licence is granted, except for first time reports
- Licence fee will be adjusted the following January, if necessary, on receipt of a report with the actual compensation for the previous year

Terms & Conditions

The legal terms that govern your licence include those set out herein as well as those found in the approved tariff including the General Provisions, as approved by the Copyright Board of Canada for each year (collectively, the “*tariff*”). If you have any questions regarding the terms, please [contact us](#).

1. In this form, you, your and licensee means the person or company applying for a licence or filing a Music Licence Form. We, our, us and SOCAN means the Society of Composers, Authors and Music Publishers of Canada. Works means any or all of the musical works in SOCAN's repertoire.
2. A copy of any tariff may be obtained from SOCAN by emailing licence@socan.com or calling 1.866.944.6223.
3. If the tariff for a year has not been certified by January 1st of that year, the last certified tariff will govern until the new version is certified, at which time adjustments will be made to reflect the certified tariff for the year.
4. This licence will automatically renew on January 1st unless terminated by either party upon 30 days' notice in writing.
5. The licence fee, plus applicable taxes, will be calculated in accordance with the terms of this licence based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
6. You will keep records of all information required to calculate the licence fees.
7. The licence fees and report forms are due no later than January 31st of the year covered by the licence, or within ten days of any adjustments.
8. Report forms of the actual compensation paid for entertainment during the year and payment of any adjustment of the licence fees is due no later than January 31st of the year following the year for which the licence is issued or within 10 days of any adjustments. If the fee due is less than the amount paid, SOCAN shall credit the licensee accordingly.
9. The tariff defines “compensation for entertainment” as the total amounts paid by the licensee to, plus any other compensation received by, all performers, for entertainment of which live music forms part. It does not include expenditures for stage props, lighting equipment, set design and costumes, or expenditures for renovation, expansion of facilities or furniture and equipment.
