This document contains important information and is incorporated into the Terms and Conditions of Stay and Waiver of Liability per section 9. In the event of any conflict or inconsistency between this document and the Terms and Conditions of Stay and Waiver of Liability, this document shall prevail.

Due to the unprecedented nature of the COVID-19 pandemic, SOCAN has implemented reasonable precautions for SOCAN Members visiting the SOCAN Houses, including cleaning protocols and expanded 14-day turnaround times between visits. This document provides notice of the additional risks of travelling to the SOCAN House during the COVID-19 pandemic.

Acknowledgement of Risk

By travelling to the SOCAN House, you acknowledge that the Government of Canada has advised Canadians to avoid all non-essential travel outside of Canada and that you may:

- have difficulty entering the foreign country;
- be required to quarantine for 14 days in a designated facility, at your own cost;
- be required to have proof of a negative COVID-19 test result;
- have difficulty returning to Canada;
- have difficulty obtaining travel insurance and difficulty accessing essential products or services; and
- may have to remain abroad longer than expected.

The decision to travel to the SOCAN House is your choice and is at your own risk. For clarity, SOCAN recommends SOCAN Members to not travel internationally at this time. In addition, you agree not to have any outside guests at the SOCAN House.

Should you be denied entry to the foreign country, we may refund the SOCAN House maintenance fee paid.

You acknowledge that prior to travelling to the SOCAN House, you will contact SOCAN if:

- you develop any flu-like or other COVID-19 symptoms;
- have been in contact with an individual who has been diagnosed with COVID-19; or
- have been in contact with an individual who has been exposed to a person diagnosed with COVID-19.

SOCAN maintains the sole discretion to revoke access to the SOCAN Houses at any time.

Compliance with Health Canada and Regional Guidelines

If you live in or are traveling from Canada, you acknowledge that you will follow the guidance provided by Health Canada and your home province. Regardless of where you live or are traveling from, you acknowledge that you will follow the guidance provided by your own government and the government of the foreign country (and, if applicable, state) you are travelling to. Failure to do so will be at your own risk.

We recommend you visit Health Canada (<https://www.canada.ca/en/health-canada.html>) and consult the Government of Canada's COVID-19 travel website (<https://travel.gc.ca/travel-covid>) before your trip to review and follow the latest updates and guidelines on COVID-19 to keep yourself protected.
