E.	If such Writer(s) have already provided SOCAN with banking information, SOCAN will apply those bank details for the deposit of Writer's Royalties unless otherwise directed now or in the future by either Publisher or directly by the Writer via the SOCAN Direct Deposit form;				
F.	Publisher may terminate this direction upon written notice to SOCAN, and SOCAN shall cease to remit the Writer's Royalties payable to the writer(s) as of the end of the full calendar quarter following receipt of the Publisher's written notice.
